Note: Vendors are required to clean up after their animals and their area after the event.

Terms and Conditions for Participants

Animals must be leashed or crated at all times.

Animals over 13 wks of age must have proof of current rabies vaccinations which should accompany the animal to the pet fair. Animals under 13 wks of age must be vaccinated for distemper, parvo and other vaccinations as recommended by standard veterinary practice.

Animals should be healthy and free of infectious disease such as upper respiratory infections, gastrointestinal infections as well as other conditions such as fleas, ticks, ear mites, ringworm and worms which can be transmitted to other animals and humans.

It is expected that adoption agencies comply with standard pre- and post-adoption practices including application and evaluation process (i.e. animal matching, veterinary and personal references) as well as provide resolution of post-adoption issues.
